SECURITY COUNCIL (SC)

“PEACE AND SECURITY; THE SECURITY COUNCIL HAS PRIMARY RESPONSIBILITY FOR THE MAINTENANCE OF INTERNATIONAL PEACE AND SECURITY. IT HAS 15 MEMBERS, AND EACH MEMBER HAS ONE VOTE. UNDER THE CHARTER OF THE UNITED NATIONS, ALL MEMBER STATES ARE OBLIGATED TO COMPLY WITH COUNCIL DECISIONS. THE SECURITY COUNCIL TAKES THE LEAD IN DETERMINING THE EXISTENCE OF A THREAT TO THE PEACE OR ACT OF AGGRESSION. IT CALLS UPON THE PARTIES TO A DISPUTE TO SETTLE IT BY PEACEFUL MEANS AND RECOMMENDS METHODS OF ADJUSTMENT OR TERMS OF SETTLEMENT. IN SOME CASES, THE SECURITY COUNCIL CAN RESORT TO IMPOSING SANCTIONS OR EVEN AUTHORIZE THE USE OF FORCE TO MAINTAIN OR RESTORE INTERNATIONAL PEACE AND SECURITY.” **SOURCE:** WWW.UN.ORG/SECURITYCOUNCIL/

INTERNATIONAL COURT OF JUSTICE (ICJ)

“THE INTERNATIONAL COURT OF JUSTICE (ICJ) IS THE PRINCIPAL JUDICIAL ORGAN OF THE UNITED NATIONS (UN). IT WAS ESTABLISHED IN JUNE 1945 BY THE CHARTER OF THE UNITED NATIONS AND BEGAN WORK IN APRIL 1946. THE SEAT OF THE COURT IS AT THE PEACE PALACE IN THE HAGUE (NETHERLANDS). OF THE SIX PRINCIPAL ORGANS OF THE UNITED NATIONS, IT IS THE ONLY ONE NOT LOCATED IN NEW YORK (UNITED STATES OF AMERICA). THE COURT’S ROLE IS TO SETTLE, IN ACCORDANCE WITH INTERNATIONAL LAW, LEGAL DISPUTES SUBMITTED TO IT BY STATES AND TO GIVE ADVISORY OPINIONS ON LEGAL QUESTIONS REFERRED TO IT BY AUTHORIZED UNITED NATIONS ORGANS AND SPECIALIZED AGENCIES.”
